A. BHS Director of Projects- Erin Harris

- B. Society COO/Director of Operations- Chip Gallent
 - Erin and Chip introduced themselves and gave a background of their history with the BHS
 - Erin and Chip gave a presentation to the House of Delegates on a new initiative by Barbershop Harmony Society for those at Harmony Hall visiting other districts at their conventions.., thus the reason they are here.
 - An update was provided as to what they are doing at Harmony Hall and where your money for dues is going.
 - The primary message is that the members know that if you have a question or need to contact Harmony Hall to start with Customer Service. There is a group of trained people that can answer most questions and if they can't you will be put in contact with someone that will.
 - In addition the importance of a good chorus director is in the retention of membership. For this reason Society is holding a Bi-Annual event to promote Barbershop to current Chorus Directors such as High School and College. This is a initiative to get these directors involved in Barbershop in hopes they will join and became Chorus Directors with the Society. Chip suggests that one thing the Chapters could do is to get involved with the Schools Choir and volunteer to help them with Stage Props, Ticket Sales, Music, etc. This has proven to be the single best idea for helping promote this effort for Director Involvement.
 - Where is the Society going in the future?... They offer surveys and ask that you fill them out; Chip assures us everyone is read and acted upon.
 - The good news is BHS is currently not the best kept secret anymore. This has been a
 mantra of the society for the last few years... and it is now starting to pay off with
 Social Media views and interactions going through the roof.

social media they are encouraged to forward the media to BHS and let them assume that risk by letting them decide to post it for you.
