In late spring, we had a very successful Spring Convention right back in Orlando. With many quartets and choruses back competing, it was a great barbershop environment in which to be. With the Harmony Market Place back in town. there was certainly something for everyone. Many thanks to our convention team which continues to put on excellent conventions each and every year.

With the arrival of July, our barbershop thoughts turned to our Society's International Convention which was held in Toronto, Canada. This year's convention was the highlight of this year's 75<sup>th</sup> Anniversary of our Society. Toronto didn't disappoint (as a chorus and a host city) and neither did our competing quartets and chorus.

Another mid-summer Society event is Harmony University. As a past attendee (from the beanie days), I can tell you that the experience at Harmony "U" is unbelievable! Whether you want to sing better, learn to arrange songs, enjoy the camaraderie or seemingly a million other things, it all happens at Harmony "U"! Rumor has it that future Harmony "U"s will be moving to Belmont University in Nashville!

Back to the Sunshine District and its unequaled Labor Day Jamboree (LDJ). Mark Schlinkert (with a little help) continues to bring unequaled talent to the stage at LDJ. While the shows are without compare in our state, LDJ features numerous activities in which to further enjoy the camaraderie of barbershopping.

Have you been active in your Chapter or District leadership team and would like to get together with

others that also love to sing but also contribute through their leadership? Look into the Confederate Harmony Brigade which meets over a weekend somewhere in the Southeast (moves every year). This group is comprised of leaders from the Dixie and Sunshine Districts and typically meets the weekend following our Labor Day Jamboree for fun and a lot of singing.

Not long from now we'll be returning to Orlando for our Fall Contest which we hope will be as successful as the convention held there in the spring. Also upcoming will be our Leadership Academies (LeadAc) in which our Chapter Leadership teams can come and learn about their positions within the chapter and also share their ideas with others in their position on how best to do their job at the chapter level.

Lastly, if you're a Director or wanna-be Director you may want to attend our Chorus Director Workshop Intensive (CDWI ) school. This school can help make you a better director whatever your current level of experience or expertise.

Obviously there is no lack of things to do within our barbershop community. However, it's up to you to take advantage of some or all of these opportunities.

Finally, I'd like to address the future direction of our Society. As we all are aware, our Society has been experiencing a slow decline in membership over the last 20 - 30 years. Our past leadership has focused on membership for many of those declining years and despite our best efforts, we've slowed the pace but have not been able to turn it around. As a barbershopper over those past 20 years, I, like many of you, have seen and been involved in many of those efforts.

However, with the leadership of our new Society Executive Director/CEO, Marty Monson, I believe we are finally on a path that may yield the results for which we've all been searching. Through his efforts and those of the Society staff and Board of Directors, tremendous progress has been accomplished in working with numerous organizations that can help us. One such contact has been with the American Choral Directors Association (ACDA). #### **DISTRICT BUSINESS**

#### MORE CHAPTER REQUIREMENTS

Yeah, I know—more bugging us about stuff that needs to be done. What is this, a singing society or a paperwork society? Geeze!!

Anyway here we go:

Remember the last Sunburst and my article that reminded us all about the requirements that keep us legal? You know, state incorporations, taxes, ASCAP, BMI/SESAC—those things. Well, here we are nearly at the close of the year and I want to give you an update on those requirements.

#### **State Incorporations:**

Really great job folks---All but one chapter has filed with the state for nonprofit status; however, three of our chapters who have filed with the state still need to update the chapter records with the society. I'm sure that will be corrected soon.

#### Taxes, Taxes, Taxes:

Another annual housekeeping function regards filing your taxes. Based again on the financial records posted on the society ebiz page, all but three of our chapters have filed the chapter 990 for last year. Again, the tax documents may have been filed but the chapter records need to be updated.

#### **Financial Review**

There is one other "business" type requirement that has been somewhat ignored and that is the Financial Review. Ten, that's right, ten of our chapters, are delinquent in that requirement. And delinquency in any of the requirements puts the chapter in jeopardy of incurring penalties including disqualification from competition. You can check to see if your chapter is in this category by simply going to the chapter financial records on ebiz, If you have questions or need assistance, let me know.

#### **ASCAP**

Let's start thinking about 2013 and your ASCAP payment. If you chapter had a performance where admission was charged, then you must pay ASCAP fees. The fee is \$235.00 if your chapter does not gross more than \$51,111.11 in ticket sales for ALL performance(s) during the year of 2013. When submitting your fees, please fill out SECTION A of the ASCAP submittal form and mail it with a check made out to BHS for the minimum amount - \$235.00. This process applies to 95% of

our chapters. Keep in mind the annual minimum fee is just that- an annual fee, not a per show fee.

If your Chapter grosses more than \$51,111.11 in ticket sales for <u>ALL</u> performance(s) during 2013 check the procedure at: http://www.barbershop.org/document-center/category/71-show-clearance-and-legal-ascap-etc.html. The ASCAP form is to be completed to comply with the agreement between The Society and The American Society of Composers, Authors and Publishers (ASCAP). You should submit this form to your District Secretary (me). My Address is:

Once again, checks should be written out to the "Barbershop Harmony Society" NOT ASCAP. **DO NOT SEND ANY PAYMENTS DIRECTLY TO ASCAP.**

Verify with Secretary that Annual Financial Review was reported on ebiz.

Verify with Secretary that State Incorporation information was reported on ebiz.

to let us know your thoughts and concerns as we move forward. You will be hearing much more about this in the weeks to come, so please, when asked for your feedback, let us know how you really feel.

Speaking of letting us know how you really feel, you know that my cell phone is on 24/7, 813.997.3588, and you can always give me a call if there's something that I can help you with. Ten o'clock at night is pushing it though. If you would rather reach me by e-mail, evp@sunshinedistrict. org goes directly to me. It has become increasingly important that the communication avenues always remain open and I think that you will find that your Board of Directors and District Committee Chair people will get back with you in a timely manner. Thanks to our new Webmaster, Roger Smeds, and all those who help keep the Website up to date. In case you didn't know, there is a link on the website to sign up for Sunshinenet. #### PLEASE - UPDATE YOUR EMAIL ADDRESS

We have over 1,400 members of the Sunshine District. We have recently joined an e-mail marketing group called Constant Contact, that allows us to keep every member informed of District events and provide information on a timely basis. The email addresses we use for this important communication process were and are obtained from the email addresses each member provides when he applies for membership. The addresses are kept on file by the Chapter Secretaries and the Barbershop Harmony Society. Here is the problem: it appears that up to 50% of the email addresses for members listed by the Barbershop Harmony Society data base are old non-functional email addresses, belong to persons who are are no longer members or members who may have moved to another District.





Sunshine District has had many singing dentists over the years, but I believe that Steve Aliapoulios was the only one who could sing in Greek. I never actually heard him do so on the stage in one of his many presentation quartets, but I have frequently heard him emit short bursts of words which he always claimed were Greek (none of his listeners really had any idea). The fact that he always smiled when reciting these phrases led us to believe that they were friendly words, but only he knew for sure.

Steve's sudden death this summer was a great loss to everyone who knew and loved him during his long life. I am one of those people. I will leave it to others, who are more knowledgeable, to detail the high points of his life. I just want to add my own tribute to a man who I admired, respected and was always delighted to see and joke with at barbershop gatherings.

I first got to know Steve when we served together on the Sunshine District Board of Directors. His calm and patient approach (except for the brief comical tirades in Greek) to all issues kept these gatherings on target and free from stress. If a board member did introduce a stressful topic, Steve would find a

way to introduce some humor that usually led to a solution without unnecessary disagreement. He could have escalated this skill effectively to the U.S. Congress, except that he was quite content to practice dentistry and sing the old songs.

When I was elected District President in 1998, I was determined to celebrate the Sunshine 40th Anniversary in 1999 with gusto, that included T-shirts, mugs and other gee-gaws to proclaim our longevity. Some of our members were openly concerned about these expenditures, especially on top of the cost of the new Young Men In Harmony campaign chaired by Ned Fogler; but a few, including Don Loos, Larry Swan and Steve rallied round and helped make it happen. I will always remember Steve volunteering his artistically-talented wife Donna to create a 40th Anniversary logo and related designs for our campaign (of course, he was confident that she would volunteer without hesitation). I learned then that the two of them were the most genuinely friendly and giving couple that I have ever encountered.

I was fortunate to spend a few days with Steve each year at barbershop gatherings. Looking back, I wish we had more time together, because Steve was the kind of guy that brought cheer to everyone around him. I will miss him. but my memories of our times together will last throughout my life.

- Have the Secretary send notices to the membership of the Annual Chapter Meeting.
- Receive the coming year's proposed slate of officers from the Nominating Committee.
  - Give a copy of the proposed slate to the chapter secretary for inclusion in the record.
  - Read the proposed slate weekly prior to the Annual Chapter Meeting.

- The President is the presumptive primary chapter delegate to the Fall District House of Delegate Meeting.
   Appoint one additional chapter member as a chapter delegate and notify the District Secretary whom you have appointed. If you cannot attend the House of Delegates Meeting, designate an alternate for you, have his name read into the minutes of a Chapter board Meeting and notify the District Secretary of the alternate.
- Share with Chapter Members the Fall District House of Delegates Meeting information.

#### Secretary:

- Send required notices to the membership of the Annual chapter Meeting.
  - Standard Chapter bylaws requires notification at least two weeks prior to the meeting.
- If your chapter selects an Alternate Delegate for the Fall District House of Delegates Meeting:
  - Record the name of the alternate in the minutes of a chapter Board Meeting
  - Report the name of the alternate to the District Secretary.

With a solid plan that relied on quality singing and emotion rather than dancing or choreography, THX brought the arena to its feet with convincing renditions of Clay Hine's arrangement of "Somebody Loves Me" and David Wright's arrangement of "That Lucky Old Sun." "Alex simply let the chorus do its own storytelling through the lyrics and the music, the way those arrangements were meant to be heard," said Bruce Checca, THX Chorus manager, "and I guess it worked, because I couldn't believe it when I saw them standing at the end," he continued.

The City of Toronto was challenging, to say the least. Traffic was a nightmare and thus moving from the Chelsea Hotel to rehearsal hotels, to the arena, back to the Chelsea, was time consuming and tedious. There was so much construction going on in the downtown area that everything

seemed to be at a standstill. Road construction. street repairs, building construction, detours - you name it. It was also expensive, but despite all of the difficulty, the members of THX managed to get through it, stayed focused on their goal of providing a high quality performance, and excelled on stage.

"It was a very high honor to represent the Sunshine District in Canada," affirmed Alex Rubin, "... at all times we felt the weight of responsibility toward all of the guys we love down there," he added. Until this past July 6th, it had been approximately 18 years since the Sunshine District had owned a top ten finish. THX resoundingly brought the District back into contention with a score of 84.0, one point out of a 7th place finish, with all of the judges awarding them scores that were solidly in the 400s.

"What's the plan for the future?" you ask. Director Rubin has the answer: "We will continue to work toward improvement. Our one-rehearsalper-month plan does not allow for much in the way of elaborate choreography, so we will have to continue singing better and better. Our members will have to continue taking full responsibility for learning the notes and lyrics on their own and I will do my best to make it all come together credibly. That's the plan from here forward."

# RAFFLES BY 501(c)(3) ENTITIES

Steve Moody (Bass THX and The Miamians)

Barbershop choruses, like many fraternal organizations (Kiwanis, Optimist, Elks and Moose, etc.) engage in various money making activities. A popular one has been the 50/50 drawing. You know the one. Everybody throws in a dollar and the winner of the drawing gets half the pot and the rest goes to a worthy cause such as youth in harmony. But is it legal? Well, maybe not. But, then again, a lot of things we citizens do are not strictly legal, such as driving 65 miles per hour in a 60 mile per hour zone. Now, the in-chorus drawing is usually limited to the members who are making a voluntary contribution. In our chorus, the member hardly ever kept the winnings and usually donated them back to the worthy cause.

What happens when a chorus wants to open the raffle to the public? This is a different beast altogether. The following will give some indication to barbershop choruses as to how a public raffle or drawing should (well, really must) be done.

"Drawings by Chance" (Raffles) are governed by Section 849.0935 of the Florida Statutes. This statute specifically relates to 501(c)(3) organizations. The disclosure requirements are provided in 849.0935(3)(a)-(e) – the most important of which is that the organization must disclose that "no purchase or contribution is necessary." To further this point, Section 849.0935(4)(b) specifically states that it is unlawful to "require an entry fee, donation, substantial consideration, payment, proof of purchase, or contribution as condition of entering the drawing." Ultimately, the drawing can be conducted in conjunction with the organizations request for a donation and suggesting a minimum contribution – it just has to be made clear that the contribution is voluntary. For convenience, I have provided the statute directly below and highlighted the relevant disclosure provisions, along with the provisions that relate to prohibited actions.

#### 849.0935 Charitable, nonprofit organizations; drawings by chance; required disclosures; unlawful acts and practices; penalties. -

- (1) As used in this section, the term:
- (a) "Drawing by chance" or "drawing" means an enterprise in which, from the entries submitted by the public to the organization conducting the drawing, one or more entries are selected by chance to win a prize. The term "drawing" does not include those enterprises, commonly known as "matching," "instant winner," or "pre-selected sweepstakes," which involve the distribution of winning numbers, previously designated as such, to the public.
- (b) "Organization" means an organization which is exempt from federal income taxation pursuant to 26 U.S.C. s. 501(c)(3), (4), (7), (8), (10), or (19), and which has a current determination letter from the Internal Revenue Service, and its bona fide members or officers.
- (2) The provisions of s. 849.09 shall not be construed to prohibit an organization qualified under 26 U.S.C. s. 501(c) (3), (4), (7), (8), (10), or (19) from conducting drawings by chance pursuant to the authority granted by this section, provided the organization has complied with all applicable provisions of chapter 496.
- All brochures, advertisements, notices, tickets, or entry blanks used in connection with a drawing by chance shall conspicuously disclose:
- (a) The rules governing the conduct and operation of the drawing.
- The full name of the organization and its principal place of business.
- (c) The source of the funds used to award cash prizes or to purchase prizes.

- (d) The date, hour, and place where the winner will be chosen and the prizes will be awarded, unless the brochures, advertisements, notices, tickets, or entry blanks are not offered to the public more than 3 days prior to the drawing.
- (e) That no purchase or contribution is necessary.
- (4) It is <u>unlawful</u> for any organization which, pursuant to the authority granted by this section, promotes, operates, or conducts a drawing by chance:
- (a) To design, engage in, promote, or conduct any drawing in which the winner is predetermined by means of matching, instant win, or preselected sweepstakes or otherwise or in which the selection of the winners is in any way rigged;
- (b) To require an entry fee, donation, substantial consideration, payment, proof of purchase, or contribution as a condition of entering the drawing or of being selected to win a prize. However, this provision shall not prohibit an organization from suggesting a minimum donation or from including a statement of such suggested minimum donation on any printed material utilized in connection with the fundraising event or drawing;
- (c) To condition the drawing on a minimum number of tickets having been disbursed to contributors or on a minimum amount of contributions having been received;
- (d) <u>To arbitrarily remove, disqualify, disallow, or reject any entry or to discriminate in any manner between entrants who gave contributions to the organization and those who did not give such contributions;</u>
- (e) To fail to promptly notify, at the address set forth on the entry blank, any person, whose entry is selected to win, of the fact that he or she won;
- (f) To fail to award all prizes offered;
- (g) <u>To print, publish, or circulate literature or advertising material used in connection with the drawing which is false, deceptive, or misleading;</u>
- (h) To cancel a drawing; or
- (i) To condition the acquisition or giveaway of any prize upon the receipt of voluntary donations or contributions.
- (5) The organization conducting the drawing may limit the number of tickets distributed to each drawing entrant.
- (6) A violation of this section is a deceptive and unfair trade practice.
- (7) Any organization which engages in any act or practice in violation of this section is guilty of a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083. However, any organization or other person who sells or offers for sale in this state a ticket or entry blank for a raffle or other drawing by chance, without complying with the requirements of paragraph (3)(d), is guilty of a misdemeanor of the second degree, punishable by fine only as provided in s. 775.083.
- (8) This section does not apply to the state lottery operated pursuant to chapter 24.

History. -s. 1, ch. 84-181; ss. 1, 2, ch. 88-115; s. 216, ch. 91-224; s. 1, ch. 96-253; s. 1825, ch. 97-102; s. 1, ch. 97-108.

Hopefully, this will give some insight to chorus leaders planning a raffle venture. I know that it can be very rewarding indeed. My friend, Dick Little, of the Coastmen told me once that they raffled off a new car and made a ton of moola. So do not be discouraged by the law. Just follow it and you will be fine. If not, you can be fined....or worse.



# Bart Van de Mark V. P. Chapter Development

# The Sunshine District will conduct another VLO (Very Large Quartet) contest at the Fall (2013) convention in Orlando with the following conditions and parameters.

Please note the changes in section d.

- A VLO shall consist of five to eleven singers.
- b. All singers shall be members of the Sunshine District, although not necessarily the same chapter.
- c. Each singer shall possess an all-events pass.
- d. A SUN VLQ may include no more than 50% of its members who are members of any current registered quartet. IE: in a VLQ of 8 members, 4 may belong to a registered quartet; in a VLQ of 9, 4 may belong to a registered quartet; 10, 5; 11, **5**; etc

Ed: This will hopefully open small ensemble opportunities for new and/or inexperienced singers to be part of a fairly competitively even contest.

e. The VLQ contest shall be conducted as part of the chorus contest, and shall be included in the draw for Order of appearance.

Ed: An opportunity to perform to a larger audience.

- f. VLQs shall compete in one of three categories
  - i. Youth (26 and under),
  - ii. Senior (55 and older),
  - iii. Regular (everyone else)

#### with champions in each category.

- g. All members of a VLQ competing in the "Youth" and "Senior" classifications shall meet the age restrictions for that category in order to qualify for competition.
- h. VLOs competing in the "Regular" category may consist of a mix of age group singers.
- i. The completion set shall consist of two songs selected by the VLQ which meet the Society Standards for Barbershop completion.
- j. A VLQ shall enroll in the contest via the Society Website.
- k. The official judging panel assigned to judge the convention contest will score a VLQ using the same judging standards used for quartets and choruses.
- 1. Champions shall be determined for each competition category.
- m. A Scoring Summary shall be created listing all of the VLQ's and their scores. This would only be a Sunshine District Report.

n. There would be no formal evaluation schedules for the VLQs. However, a VLQ would have the option of contacting the scoring judges post contest and ask for a written evaluation of their performance.

Editorial from my perspective as the A: <u>Chapter Development (Membership) VP for the Sunshine District</u> and from my perspective as B: <u>Music Director for the Martin-St. Lucie Mariners</u>.

A:

- Smaller chapters might now have a chance to perform at a convention in a contest.
- If we continue to next Fall, the concept will provide a focus opportunity for chapters which suffer from snowbird depletion in the Summer months.
- What an inter-chapter opportunity!
- What an opportunity for a chapter to sponsor a youth ensemble from a local school! Think about it.

B:

- It'll create some focus for the Summer months.
- It'll allow me to sing facing the audience.
- It'll give coaching opportunities for other members of the chapter.
- We'll treat VLQs like quartets and allow them the opportunity to perform in front of the chapter with the understanding that VLQ rehearsals will be separate from the chapter meeting.
